Fund Objective

The investment objective of the fund is to provide a medium whereby investors can obtain undivided participation in a diversified portfolio of money market instruments and assets in liquid form.

Portfolios in this category are tilted towards a higher money market, cash or short dated fixed income exposure. While statistical analyses of markets' returns indicate that investments in money market instruments has a high degree of implicit capital protection, it also comes with a risk of delivering returns below the inflation level over a period of time.

Fund Universe

Investments in the portfolio will consist of short-term deposits and NCD's, commercial paper, asset-backed commercial paper, government issued treasury bills and debentures, interest rate swaps, and cash equivalents that fall under South African jurisdictions.

Investment Strategy

The fund can be used as a traditional savings tool and is well known to be a low-risk solution for investors who wish to diversify their portfolio away from risky asset classes. The primary reason investors seek out this alternative is for the highly predictable nature of investment return. The main objectives are to maximize interest income, preserve capital, and provide liquidity. The fund utilizes a combination of money market instruments such as bank issued negotiable certificates of deposit, short-term commercial corporate paper, government issued treasury bills, and overnight call-deposits with AAA-rated international banks.

Who should be investing

The fund is suitable for investors who have short-term investment objectives that require regular income distributions, preservation of capital, and access to capital on an immediate basis.





Glossary of Terms

Standard Deviation is a statical measure of the dispersion of returns for a given security or market index.

Sortino Ratio measures the risk-adjusted return of an investment asset, portfolio, or strategy. It is a modification of the Sharpe ratio but penalizes only those returns falling below a user-specified target or required rate of return, while the Sharpe ratio penalizes both upside and downside volatility equally.

Sharpe Ratio is a measure for calculating risk-adjusted return. It is the average return earned in excess of the risk-free rate per unit of total risk.

Max Drawdown is the maximum loss from a peak to a trough of a portfolio, before a new peak is attained. Max drawdown is an indicator of downside risk over a specified time period.

Total Investment Charge (TIC) is the sum of the Total Expense Ratio (TER) and the Transaction Costs (TC).

Total Expense Ratio (TER) is the global standard used to measure the impact that the deduction of management and operating costs has on a fund's value. It gives you an indication of the effects these costs have on the future growth of your investment portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. Also, the current TER may not necessarily be an accurate indication of future TERs.

Transaction Costs (TC) is a necessary cost in administering the fund and impacts fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER. Calculations are based on actual data where possible and best estimates where actual data is not available.
